Amendments/Clarifications in "The Punjab Custom Milling of Paddy Policy (Kharif 2018-19)"....regarding.

Please refer to this office Memo No. RP1-(30)-2018/3008-3010 dated 04.09.2018, on the subject cited above.

The clause 4 (vii) of "The Punjab Custom Milling of Paddy Policy (Kharif 2018-19)" provides for the following-

"A miller has to maintain a CIBIL score of 600 and above and a CIBIL Micro Small and Medium Enterprises (MSME) Rank (CMR) score of 6 and below."

In this regard, it has been reported that the millers' individual or mill's CIBIL 3. Score/CIBIL MSME Rank has been reported to be low due to some past irregular financial transaction. However, they have now cleared the irregularity with the Bank or have made an arrangement with the Bank for clearance of the irregularity. However, the same are not being reflected in their CIBIL Score, as the updation of CIBIL Score takes some time. In this regard, it is clarified that

The Millers, who have cleared their irregularities with the Bank, may be considered for allotment subject to the submission of "Irregularity Clearance Certificate/NOC" from the

concerned bank/leader of the consortium of the banks of the miller.

b. That the concerned Bank will have to certify that they would not have any lien on the paddy

allotted/stored with the miller by the State Agencies.

In addition to this, it is also clarified that those millers who refuse to mill more than 4. 5000 MT of paddy to avoid submission of Bank Guarantee as per the provisions of Clause 5 (c) (xv) of the ibid policy, their maximum permissible allocable paddy may be freezed at 5000 MT for three years i.e. up to KMS 2020-21 and they may also not be issued release orders above the quantity of 3000 MT i.e. the quantum of R.O. paddy permissible for above 4000 M.T. but less than equal to 5000 M.T. This would be irrespective of the provisions of the Custom Milling Policies of the concerned KMS.
